BY-LAW NO. 2076

A By-law to exempt certain defined classes of shops in the City from the Shop Closing Provisions of the "Municipal Act".

THE CITY COUNCIL of the City of Surrey, in open meeting assembled, ENACTS AS FOLLOWS:

1. For the local convenience and well-being of the residents of the City, the classes of shops as set forth and defined in Schedule "A", which is hereunto annexed and made a part of this by-law, are hereby completely exempted from the provisions of Section 858 and 859 of the "Municipal Act", being Chapter 255, of the Revised Statutes of British Columbia, 1960.
2. Where the term "shop" is used in this By-law or the Schedule hereto it shall have the meaning assigned to it by Section 857(1) of the "Municipal Act", being Chapter 255, of the Revised Statutes of British Columbia, 1960.
3. "Surrey Shops Regulation & Exemption By-law 1963, No. 2045", and "Surrey Shops Regulation & Exemption By-law, 1963, No. 2045, Amendment By-law, 1963, No. 2062", and "Surrey Shops Regulation & Exemption By-law, 1963, No. 2045, Amendment By-law, 1963, No. 2063", are hereby repealed.
4. This By-law may be cited for all purposes as the "Surrey Shops Exemption By-law, 1963, No. 2076".

SCHEDULE "A"

Class

1. Automobile Dealers - new

Shop where the principal or only trade or business carried on is the sale by retail of new automobiles.

2. Automobile Dealers - used

Shop where the principal or only trade or business carried on is the sale by retail of used automobiles.

3. Automobile Supply Stores

Shop where the principal or only trade or business carried on is the sale by retail of equipment or supplies for automobiles.

4. Battery and Tire Shops

Shop where the principal or only trade or business carried on is the sale by retail of automobile tires and batteries or either of them.

5. Bicycle Shops

Shop where the principal or only trade or business carried on is the sale by retail of bicycles and parts therefor or the renting of bicycles.

6. Book Stores

Shop where the principal or only trade or business carried on is the sale by retail of books and magazines or either of them.

7. Builders' Supply Houses

Shop where the principal or only trade or business carried on is the sale by retail of builders' supplies including lumber, hardware, bricks, cement, sand, gravel and miscellaneous items to be used in the construction, repair or alteration of buildings and associated structures.

8. Butcher Shops

Shop where the principal or only trade or business carried on is the sale by retail of meats and poultry whether cooked or uncooked.

9. Children's Stores

Shop where the principal or only trade or business carried on is the sale by retail of clothing or furnishings for children.

10. Clothing Stores

Shop where the principal or only trade or business carried on is the sale by retail of clothing.

11. Delicatessen Stores

Shop where the principal or only trade or business carried on is the sale by retail of prepared foods, including cooked meats, preserves, pickles, relishes and salads.

12. Department Stores

Shop where any five (5) or more of the following lines or classes of goods are offered for sale by retail; that is to say,

Automobile supplies and accessories;
Builders' supplies;
Clothing, furnishings (men's and boys');
Confectionery;
Fruit or vegetable dealer;
Dry goods, ladies' clothing, fancy goods;
Millinery;
Druggist;
Electrical Supplies;
Restaurant, cafe, public dining room or
eating house;
Dairy, retail;
Photographer or dealer in photographic supplies;
Hardware;
Paint;
Books;
Plumbing Supplies;
Heating Supplies;
Musical Instruments;
Sheet Music;
Bakery Goods;
Furniture;
Baby's wear;
Carpets;
Chinaware;
Cosmetics;
Hats;

Jewelry;
Garden Supplies;
Leather Goods;
Shoes;
Sporting Goods;
Toys;

13. Drug Stores

Shop where a licensed pharmaceutical chemist is in attendance at all times when such shop is open for the serving of customers and where the principal or only trade or business carried on is the sale by retail of drugs, proprietary or patent medicines and surgical and first-aid supplies, whether or not other items of merchandise are sold in the shop in addition thereto. The terms "drugs", "proprietary or patent medicines" and "licensed pharmaceutical chemist" shall bear the respective interpretations assigned to them by the "Pharmacy Act", being Chapter 282, Revised Statutes of British Columbia, 1960, as amended.

14. Dry Goods Stores

Shop where the principal or only trade or business carried on is the sale by retail of staples and fancy dry goods or either of them.

15. Electrical Appliance Stores

Shop where the principal or only trade or business carried on is the sale by retail of electrical appliances and electrical fixtures, or either of them.

16. Farm Implements

Shop where the principal or only trade or business carried on is the sale by retail of implements or machinery to be used for agricultural purposes.

17. Feed Stores

Shop where the principal or only trade or business carried on is the sale by retail of feed, including hay, straw, grain, flour and fertilizer.

18. Fish Stores

Shop where the principal or only trade or business carried on is the sale by retail of fresh fish, cooked fish, cured fish or other sea foods.

19. Fuel Dealers

Shop where the principal or only trade or business carried on is the sale by retail of fuels for domestic use.

20. Furniture Stores

Shop where the principal or only trade or business carried on is the sale by retail of new or used home furnishings, including furniture, carpets, carpeting and electrical appliances.

21. Furriers

Shop where the principal or only trade or business carried on is the sale by retail of furs or items manufactured from furs.

22. Grocery Stores

Shop where the principal or only trade or business carried on is the sale by retail of food for human consumption, to be taken out of the shop, whether or not other items of merchandise are sold therein, in addition to such food.

23. Hairdressers' Shops

Shop where the principal or only trade or business carried on is that of a hairdresser as defined in the "Hairdressers Act", Revised Statutes of British Columbia, 1960, Chapter 169.

24. Hardware Stores

Shop where the principal or only trade or business carried on is the sale by retail of hardware, including garden implements, electrical supplies, glass, crockery and stoves.

25. Implement Stores

Shop where the principal or only trade or business carried on is the sale by retail of implements, including tools, power saws and parts, and air compressors and equipment.

26. Jewellery Stores

Shop where the principal or only trade or business carried on is the sale by retail of jewellery, including watches and clocks.

27. Marine Sales Stores

Shop where the principal or only trade or business carried on is the sale by retail of marine supplies, including boats, marine engines and ship chandlery.

28. Millinery Stores

Shop where the principal or only trade or business carried on is the sale by retail of hats for women or girls.

29. Motor Cycle Stores

Shop where the principal or only trade or business carried on is the sale by retail of motorcycles, including parts and equipment therefor.

30. Music Stores

Shop where the principal or only trade or business carried on is the sale by retail of radios, phonographs, tape recorders, records, musical instruments and sheet music, or any one or more of them.

31. Office Supply Stores

Shop where the principal or only trade or business carried on is the sale by retail of office supplies including office machines, office furniture and office stationery and supplies.

32. Paint Stores

Shop where the principal or only trade or business carried on is the sale by retail of decorating materials, including paint, varnish, paint solvents, tile, wall paper, and plastic decorating materials.

33. Pet Stores

Shop where the principal or only trade or business carried on is the sale by retail of animals or birds for domestic pets.

34. Photographic Stores

Shop where the principal or only trade or business carried on is the sale by retail of photographic equipment, including cameras, films, picture frames and photographs.

35. Second Hand Stores

Shop where the principal or only trade or business carried on is the sale by retail of second hand or used goods.

36. Sewing Machine Stores

Shop where the principal or only trade or business carried on is the sale by retail of sewing machines, including parts and supplies therefor.

37. Shoe Repair Shops

Shop where the principal trade or business is the repairing or dyeing of shoes.

38. Shoe Stores

Shop where the principal or only trade or business carried on is the sale by retail of shoes or footwear.

39. Souvenir Shops

Shop where the principal trade or business carried on is the sale by retail of any one or more of the following items:

Curios

Gifts

Leather Goods

Postcards

Printed Books

Sewing Notions

Souvenirs

Blankets and Wool Products

Chinaware

40. Sporting Goods Stores

Shop where the principal or only trade or business carried on is the sale by retail of goods and equipment for engaging in sports and recreational activities and including firearms and ammunition and bicycles.

41. Stationery Stores

Shop where the principal or only trade or business carried on is the sale by retail of stationery for office or home.

42. Stove Dealers

Shop where the principal or only trade or business carried on is the sale by retail of stoves, including furnaces or heaters and equipment therefor.

43. Toy Stores

Shop where the principal or only trade or business carried on is the sale by retail of toys and games, or either of them.

44. Hobby Shop

Shop where the principal or only trade or business carried on is the sale by retail of materials and supplies for or in connection with the carrying on by any person of a hobby or similar recreational pastime.

45. Barber Shop

Shop where the principal or only trade or business carried on is that of a barber as defined in the "Barbers Act" Revised Statutes of British Columbia, 1960, Chapter 24.

46. Trailer Sales

Shop where the principal or only trade or business carried on is the sale by retail of new or used trailers.
