SUBJECT: Award of Contract No. 4821-001-21

128 Street Drainage and Sanitary Improvements

RECOMMENDATION

The Engineering Department recommends that Council:

- 1. Award Contract No. 4821-001-21 to J. Cote & Son Excavating Ltd. in the amount of \$4,032,620.55 (including GST) for 128 Street Drainage and Sanitary Improvements;
- 2. Set the expenditure authorization limit for Contract No. 4821-001-21 at \$4,450,000.00 (including GST and contingency); and
- 3. Authorize the General Manager, Engineering to execute Contract No. 4821-001-21.

INTENT

The intent of this report is to seek Council's approval to award a contract for the 128 Street Drainage and Sanitary Improvements.

DISCUSSION

Scope of Work

The construction package related to this contract consists of the installation of a trunk drainage main, and replacement of aging and undersized sanitary sewers, the locations of which are illustrated on the map attached to this report as Appendix "I".

The contract permits construction from 7:00 a.m. to 10:00 p.m., Monday through Friday, in compliance with the *Surrey Noise Control Bylaw*, 1982, No. 7044.

Invitation to Tender Results

An Invitation to Tender followed the City's Purchasing Bylaw and was publicly posted on the BC Bid and City of Surrey websites. Five tenders were received for the subject contract and opened on February 28, 2025 with the following results:

The Engineer's (ISL Engineering and Land Services Ltd.) pre-tender estimate was \$4.5 million (including GST).

Evaluation

The submissions were reviewed for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond and were signed on the Tender Form.

The low bidder, J. Cote & Son Excavating Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 160 working days, as stipulated in the contract. J. Cote & Son Excavating Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that J. Cote & Son Excavating Ltd. be awarded Contract No. 4821-001-21.

Project Schedule

The contract work is expected to start April 2025 and be completed by fall 2025.


