Re-inspection fees may be assessed when an inspection of a previous noncompliance is performed (1 hour minimum charge). Electrical Safety Regulation 19(4) states regulated work must not be concealed or energized unless inspected or the inspection has been waived.

Do not let your homeowner permit expire. If an inspection request has not been received within 180 days from date of permit issuance or from last inspection date, a permit extension request must be submitted.
